POSITIVE PROFIT ALERT

This announcement is made by Progressive Path Group Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the latest unaudited consolidated management accounts of the Group, the Group is expected to record a profit attributable to owners of the Company of not less than HK\$5.3 million for the six months ended 30 September 2020 (the “**Period**”) as compared to a profit attributable to owners of the Company of approximately HK\$1.2 million for the corresponding period in 2019. The Board considers that the expected substantial increase in profit is primarily due to the recognition of non-recurring government grants of approximately HK\$5.9 million under the Anti-epidemic Fund launched by the Hong Kong Special Administrative Region Government during the Period.

As the Company is still in the process of finalising the unaudited consolidated interim results of the Group for the Period, the information contained in this announcement represents only a preliminary assessment by the Board with reference to the latest unaudited consolidated management accounts of the Group and other information currently available, which have not been audited or reviewed by the auditor of the Company, nor have been confirmed by the audit committee of the Company. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the Period which is expected to be published on 27 November 2020.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
